Heidi Ganahl added, "While I may not align with every aspect of what's happening in Colorado today, I am dog-gone thrilled to support Proposition 129. This initiative represents a significant step forward in improving care for our pets. By addressing the veterinary shortage, it will provide better and more affordable care for all animals. Proposition 129 is truly a win-win: it benefits rural communities, as well as pet owners in our cities and suburbs."

Proposition 129 will be on the ballot this upcoming election, and its passage would mark a significant advancement in veterinary care across Colorado. The initiative promises not only to alleviate the burdens on existing veterinary services but also to ensure that all pets, regardless of their location, have access to quality healthcare.
